Jharkhand Bijli Vitran Nigam Limited (JBVNL), a distribution licensee under the provisions of the Electricity Act, 2003, invites an emergent Expression of Interest (EOI) for selection of vendors for the supply of wind power under a Short-term/long-term arrangement.

1. Background:

In accordance with the RPO trajectory notified by JSERC, the Wind RPO component constitutes one of the mandatory categories of renewable energy that obligated entities must fulfil, based on a prescribed percentage of their total energy consumption. In this regard, and to ensure compliance with the Renewable Purchase Obligation (RPO) targets for the forthcoming years, JBVNL is planning to procure renewable energy specifically wind power primarily through open-market procurement.

2. Scope of Work:

The interested agencies shall be capable of supplying 100 MW of power to JBVNL and they will be required to supply wind power to JBVNL under a Short-term or long-term arrangement.

3. Eligibility Criteria:

1. The agencies may offer power up to the 100 MW for the respective periods. The supply of power may be offered from one or more sources, and it shall be considered only if the respective project(s) have achieved COD on or after 31st March 2024.
2. The quantum of power offered by the agency shall be firm power for the duration mentioned above.
3. If the agency is a company, he/they must submit the details of their Company as per Annexure 'I' of tender specification for consideration of their bid.
4. If the agency is a Trader, he/they should submit a copy of the valid category of Trading License or equivalent Trading License issued by the Appropriate Commission.

4. Submission Requirements

Interested Suppliers may submit their Expression of Interest along with the following documents:

- Letter expressing interest.
- Firm/organization profile and experience details.
- List of similar assignments executed in the past 5 years.
- PAN and GST registration.
- Financial quote in the prescribed Price Bid Format (Annexure-I)
