Even beyond the contractual delivery schedule of said P.O and in spite of consistent follow up by this office, your firm miserably failed to supply the full ordered quantity. Several reminders were also served to your firm by this office but no positive response was elicited from your end. Your firm has adopted unethical business practice by not supplying the ordered quantity in confirmation with P.O.

From above position and facts, it is clear that even after constant perusal your firm did not come forward for supply of balance quantity against awarded purchase order. Thus it is quite evident that your firm has failed miserably to fulfill its contractual obligation under the said purchase order.

Accordingly, the facts & status was analysed by JBVNL and it has been decided to short close purchase order no. 120(S&P) dated 02.11.2017 and forfeit submitted security and performance BG or its equivalent amount kept back against said POs. Also, your firm M/s Crystal Cable Industries Limited, 32a Ganesh Chandra Avenue Kolkata-700013 is here by blacklisted for period of three year (from the date of issuance of communication) in JBVNL.
